# Connecting you with the body of Christ at THE TIE Spilman Memorial Baptist Church **MAY 2020**



In a 1948 speech to the House of Commons, Winston Churchill said, "Those who fail to learn from history are condemned to repeat it." This was slightly reworded from what George Santayana said in 1905, "Those who cannot remember the past are condemned to repeat it."

The same can be said for "church" history as well. For centuries the church has struggled to exist in a world that often despises and abhors the church. The church has at times been the recipient as well as the dispenser of persecution. In England the tide shifted often between Kings that embraced the Catholic Church or the Protestant Church. With every change in leadership there often followed bitter persecution of the opposing theological perspective. In Spain it wasn't any better. During the Spanish Inquisition, the DR. H. POWELL DEW, JR. Catholic Church used their influence over the government to persecute and kill thousands whose faith traditions were outside the teachings of the Holy Catholic Church.

When settlers came to America, they were fleeing religious persecution from England and Europe. America's experiment of Religious Freedom is not perfect. Over the years, there has been discrimination and persecution among "different" religions. What has emerged over the past 244 years is an understanding (albeit somewhat fragile) of how the church and the state are to coexist.

Today, churches in America do not pay property taxes on the buildings they own. Churches do not pay income taxes on money that is donated to them. Donations to churches can be tax deductible. Churches do not pay sales tax on items purchased by the church (yes, they pay when items are purchased, but it is reimbursed.) Ministers' housing allowance is not taxed for federal or state income tax purposes. Some ministers can even elect out of Social Security if they have a religious objection. So much care has been taken to make sure the church remains free from being entangled in governmental regulation and oversight.

Yes, the church needs to build its buildings to current building and fire codes. We need to follow sanitation and safety guidelines for health and safety. These rules are established for everyone's common good. But the church quickly draws the line in areas of faith and practice. Churches and denominations establish their own doctrine, covenants, bylaws, and constitutions. Churches select their own ministers and staff according to their own faith traditions and convictions. Churches set their own schedule for times of worship, prayer, and Bible Study. Each person and group follows their own conscience in matters of faith. As a Baptist, I may not agree with my neighbor down the road about their theology, faith or practice, but I will defend their right to practice it because I want my neighbor to defend my right to exercise my faith. ## Hope Preparatory Update April 2020— from Diane Spear

Hope Preparatory has been navigating the global pandemic with many challenges and unexpected blessings along the way. We have shifted to daily online Zoom classes. We begin with a chapel each morning and then the students go to class with their teachers for review of their daily work. We distribute homework packets to students every two weeks and pick up the past two weeks' work for grading. We have regular visits by our enrichment teachers such as Dr. Joan Perry's live science lesson and garden update this past week, which you can see posted on our Facebook page. The garden is growing beautifully, and we can't wait for harvest time with the children. The children always enjoy seeing the familiar faces of our wonderful enrichment teachers.

In addition to Zoom classes, our staff is keeping in close phone contact with parents for academic support and personal encouragement during this uncertain time. We have 3 nurses among our parents, so please keep them in prayer if you think of them. The staff is also taking this opportunity for some added professional development through an online classical education class which is now being offered free through Classical U. Our plan is to travel to Louisville, Kentucky for teacher training in July as we did last summer.

We are so thankful for God's provision in the launch and operation of our school and are continually thankful to Spilman Church, as you are a huge part of His provision. This past week God demonstrated His faithfulness to us yet again even in a time when we feel all we can do is rely on Him. During this spring we have educated applicants in the process of applying for the NC Opportunity Scholarship vouchers which are selected in March by lottery. Every applicant that qualified, applied, and we found out last week that every one of our applicants that applied for the OS was granted the scholarship! Praise God for His provision as we look towards another fruitful year of Christian education and family ministry. We are expecting 25-35 students in grades K-3 next year.

We so appreciate and covet your prayers and support as we continue to step forward in faith into God's good plan for Hope in Kinston.

# **Our Fragile Religious Freedom**

In recent weeks, there has been a lot of turmoil in our world. Over the past six weeks, a new virus has spread around the world infecting over 3 million people which includes 1 million people here in the United States. Over 55,000 people in the United States have died from the coronavirus. In attempts to stop or slow the spread, drastic measures were implemented by the President and our Governor for everyone – airline travel was restricted, businesses were closed, schools and colleges were closed and classes went to an online format, sporting and entertainment events were canceled and even churches were closed.

In an attempt to lessen the financial impact, the government began a program called the "Payroll Protection Plan (PPP)." Businesses and nonprofits (including churches) were encouraged to apply for a grant to cover payroll, utilities, and rent for 10 weeks.

I have read the literature related to the PPP. I have listened to seminars about PPP. I have spoken with friends who lead various size churches that have applied for the PPP grant. For some churches, their response is, "We really need this money now to get us through this uncertain time." People are fearful of this virus, the loss of income due to their business closing, the family stress of closed schools. Churches can also fear the future and all the changes that have and will continue to come. Fear often causes us to make decisions, that otherwise, we would not have made.

As the PPP unfolded, I thought about the story of Jacob and Esau in Genesis 25:29-34. Esau had been out in the field and was weary and hungry. Jacob saw this as an opportunity to get Esau to trade something that was very valuable but unable to fill his hungry stomach TODAY. So, in exchange for bread, a stew of lentils, and drink, Esau gave away his birthright (inheritance) to Jacob.

Now I will be the first to say there are not any stated "strings attached" to this offer of Payroll Protection. But you and I know, one day, some forces inside and outside the government will insist on changing the current arrangement between the church and the state by removing some of the protections the churches experience today because the church was willing to accept financial support from the US tax payers. Has the church traded our fragile religious freedom for a bowl of soup?

I am so glad the Trustees of Spilman Memorial Baptist Church understand this offering of payroll support may soon come with strings attached. They remember the past, and are not tempted to trade our freedom for a few months of financial support. I pray that the actions of *some churches* that have capitulated in a moment of weakness, have not set *all churches* on a path which may cause us to forfeit the fragile religious freedom we experience here in the United States of America. May that be the prayer of us all.
